### ENTRY INFORMATION:

Class fees: \$15 each members, \$20 each non-members

Office fee: \$5 per entry

Facility fee: \$15 per entry

Stall fee: See website for each show for further information.

Late fee: If received after the closing date and space is available: \$10 per class.

### GENERAL INFORMATION:

Rides will be accepted on a first come, first served basis with a limited number of rides available.

**Payment must accompany entry. No refunds will be made after the closing date for any reason.**

Show will be held rain or shine unless facility cancels. Information about warm-up and competition arena will be made available on the website.

Ribbons will be awarded for 1<sup>st</sup> thru 6<sup>th</sup> place. All tests and ribbons must be picked up at the show.

Music for freestyles must be on a CD or cassette tape with written instructions on when to cue the music and turned into the show secretary no less than 1 hour before the start of the freestyle class.

Attire is casual but participants are expected to wear proper headgear and footwear when mounted. All horses must wear their assigned bridle numbers at all times.

No dogs please! All children under 16 must be supervised!

**Opening Date is one month before the show. Closing date is IN SECRETARY'S HANDS 7 DAYS PRIOR TO THE SHOW!! AFTER CLOSING DATE LATE FEE WILL BE CHARGED—NO EXCEPTIONS!** A copy of negative coggins within 12 months must be sent with entry, or the entry is incomplete and will not be accepted! Please do not bring horses suspected of having a contagious disease.
